Return to Learn

Return to Learn. On March 15, 2020, few of us were considering the significance of those 3 words. Fifteen weeks later, those words have been contextualized and have taken center stage in our workplace conversations - for you and for those of us who serve and support you. Professional Educators of Iowa will not be issuing an official statement on the **Reopening Guidance for Schools** put forth by the Department of Education. We continue to monitor and to make sense of the guidance shared by experts at the Centers for Disease Control, the Iowa Department of Public Health and our leaders at the Department of Education.

To be certain, we maintain the most important element in an effective classroom is a *healthy teacher*. This pandemic has served as a reminder that your personal health and safety needs are not part of the bargaining process. However, they are addressed through local policy and considered on an individual basis. Fortunately, your advocates at PEI understand policy decisions and are well-versed in connecting interests shared by labor and management. We successfully create win-win solutions every day.

Each district in the state has submitted its first draft of a **Return to Learn Plan**. Please familiarize yourself with this document, and please feel free to share suggestions/concerns with your local administration. No one has navigated these waters before, and they should welcome your feedback. If they have not done so already, you might consider a simple suggestion for your leaders to survey staff members to determine the need for personal protective equipment in your district/building.

Finally, if you have a pre-existing health condition, or live with someone who does, please share this information with your local administration. If you believe your concerns are being overlooked or dismissed, please contact our offices immediately. Workplace accommodations are available, and our staff stands ready to support you.
